## The Community of the Blessed Sacrament—Business Expo Policy

### Exhibitors will be limited to:

- “Registered” parishioners who are business owners and/or employees applying businesses
- Businesses that advertise in parish bulletin.
- Job-opportunity related ministries and/or agencies referred by parishioners and/or parish staff (i.e. St. Patrick’s Job Ministry)

### Booths:

- All booths must be family friendly.
- The Business Expo Committee has the final say on all booth content and what may or may not be displayed or sold during the Expo.
- A “booth” is defined as a 30”x90” table with two chairs. Extra maybe allocated if available.
- It is recommended that the booth be managed by at least two people—so that Exhibitors can visit other booths.

### Direct Cash Sales:

- General description of products for sale at the booth should be listed on the application.
- Exhibitors selling products in the booth should, if requested, be able to provide proof of a minimum of \$1,000,000 in liability insurance.
- Exhibitors are responsible for paying all applicable sales tax.
- All Exhibitors must collect their own sales tax.
- All items for sale must be clearly marked with price.
- Prices to remain the same throughout the Business Expo.
- Exhibits are subject to all State, Federal, and Parish laws governing taxes, health, and safety of persons and or property.

### At Booth Raffles or chance-games:

- General description should be listed on the application.

### Applications:

- All Exhibitors must complete an application and submit \$15 check to Blessed Sacrament for booth space to reserve space.
- Applications are available on the parish website and/or located in the church and parish lobbies.
- Applications will be processed on a first-come, first-served basis; space is limited—so submit application early.
- Deadline for Exhibitor applications is: February 5, 2010.
- All businesses participating in the Business Expo will have their contact information listed on the parish’s website on the Business Network page.

### Animals/Pets

- Are prohibited except for those supporting the disabled.

### Electrical:

- Electricity to booths is based on availability and will be provided on a first-come, first-served basis. No fans or heater use.

### Exhibitor Set-up Time:

- Booth set-up is from 3:00pm to 4:15pm Feb. 13.
- Spaces not occupied by 4:15pm and/or ready to open by 4:15pm on Feb. 14 will not be guaranteed.
- All Exhibitors must keep their booths open and operating from the time gates open until closed.
- No early break-downs permitted—unless Expo early release notice is given by Business Expo Committee.

### Exhibit Times:

- Saturday: February 13,
  - 5:30pm to 7:00pm
- Sunday February 14
  - 8:00am to 12:30pm

### Presentations during Exhibit Times:

- 10 minute length
- Will be scheduled on first-come, first-served application receipt basis every 15 minutes.

### General:

- The Business Expo Committee will determine the location of all booths.
- The Business Expo Committee will provide booth signs and provide a list of all exhibitors on the day of the event.
- Exhibitors will operate in a professional manner.
- Exhibitors will keep booths clean, sanitary and will deposit all waste in trash receptacles located throughout the Social Hall. Large boxes and other large trash items—dispose of in large waste bins located on the perimeter of the parish parking lot.
- The Community of the Blessed Sacrament, Expo Committee, parish staff and those attending do not take any responsibility or liability for the loss or damage that might result to a booth or its contents from causes beyond reasonable control, including, without limitation, such loss or damage as may be caused by the elements, an act of God, thieves, vandals or unavoidable accidents.
